 - 1. Projected number of participants in the MAD 74 parcels/approx 46 owners
 - 2. Will there be any changes to the assessments for FY2023?
 - a) There will be a 7.29% CPI adjustment for FY24.
 - b) This MAD Budgets are going to the City Council in May for approval (as they do every year).
 - 3. The boundaries of the MAD will remain the same 4800-5000 block of Newport Ave.
- D. Contractors for the Maintenance Assessment District:
 - 1. Naturescape owned/operated by Randy Bates has done an outstanding job of emptying our trash receptacles daily, cleaning graffiti twice a week, landscaping, and plant replacement as well as repairs to our irrigation system.
 - 2. Ecoclean Services owned by Marc Cortazzo who pressure washes Newport Ave.
- E. Non-MAD Programs and projects of interest to property owners and store owners
 - 1. **Storefront Improvement Program** was funded for FY23 and hopefully will be in the in the Mayor's final FY24 budget.
 - 2. PROW Public Right of Way Program is still being administered by OBMA.

- 3. **OB Clean & Safe Program** (which is run separately from the MAD) has been very successful. We could use more support from property owners and business owners in the business districts to pay for additional maintenance and replacement of signs, damaged fencing, broken trash cans, etc.
 - a. Ambassador Program in downtown Ocean Beach starting May 6 soft launch.
 - b. Sidewalk Beautification Initiative
 - c. Graffiti Abatement
 - d. Community Clean Ups at least quarterly
 - e. Letter of Agency compliance
 - f. Increase B2B communication within the Newport Avenue Maintenance Assessment District.
