

February 2021 Accomplishments

Friends of OB & Maintenance Assessment District Funds were used to:

SDNews.com reports OB Hardware at 4871 Newport Ave. is on the auction block, and present co-owner Michael DeEmidio, who bought the business from the previous owners in 2018, is moving on.

“After a lot of heavy-hearted consideration, my wife and I have decided to move out of California to be closer to family,” said DeEmidio. “We are reaching out to the community in an effort to find someone to whom we can pass the OB Hardware baton. Ideally, someone invested in the community who wants to care for this legacy and leave their mark. We will be relocating in fall, so it is pressing that any interested parties step up now.”

Parking Issues in Commercial Districts

Parking issues in the commercial districts brought to our attention.

First of all, we agree that the lack of parking has caused a hardship for a number of our local retailers. A lot of attention has been paid to opening up outdoor dining parklets for restaurants and bars. We understand that this eliminates parking in front of that business and it also does impact accessibility to retailers who are located near the parklets. During the months that the two hour parking wasn't enforced, the lack of parking became even more of a problem. Recently with the two hour parking limit again being enforced, it has helped with parking turnover. Also, the OB Planning Board pushed for a four hour parking limit in the pier lot. They will be looking at the results of this change fairly soon to see if this is causing the desired result of more accessibility in the pier lot. We were notified that a number of local businesses used the pier lot for employee parking and now with the four hour limit it has caused some problems for their workers. Clearly, every action causes some intended consequences and certainly some unintended consequences as well.

We have also heard some complaints that a few of the parklets are not used for many hours during the day and others during the evening. We're continuing to work with our members who have parklets to have the best possible outcome for the community. As the COVID restrictions lessen, and more indoor dining will be allowed, we are hopeful that a solution to the underutilization of some parklets can be mitigated.

All of these issues are part of a larger community conversation and the OB Town Council, OB Planning Board and OB MainStreet Association are all committed to working together for a balanced (yet quirky) community. We appreciate it when our members contact us with their concerns so that we can help to find a better answer. These are unprecedented times and there have been a lot of challenges. If we all work together and take a creative approach to problem solving, we'll all be better for it.

Sidewalk Vending Ordinance

What's happening with the proposed Sidewalk Vending Ordinance?

In 2018, the State of California passed SB946 which established requirements for the local regulation of sidewalk vendors. The bill's primary intent was to decriminalize sidewalk vending by requiring municipalities to penalize violations with administrative citations rather than criminal citations, in turn promoting entrepreneurship and economic success for sidewalk vendors.

The OBMA worked hard to help develop a new Sidewalk Vending Ordinance that would address the concerns. All our local groups and other groups assisted including ones from Mission Beach and PB. Many cities in the state have passed new Sidewalk Vending Ordinances since 2018 but sadly San Diego has not been one of them.

Consequently, there is no ordinance addressing the problems we are having at the foot of Newport and throughout the commercial districts even apparently during a pandemic. It is a shame that our grassy area between the pier parking lot and the Lifeguard tower has been quite literally used to death and now is mostly a sand/mud lot. City Park & Rec department has attempted to increase trash removal and cleaning however the grassy area needs to be re-sodded and allowed to come back.

We are hopeful that the San Diego City Council will follow through and finally pass a reasonable Sidewalk Vending Ordinance that can preserve our park at the foot of Newport for the enjoyment and use of our residents and visitors so that they can access the beach area. We will continue to monitor the situation and participate in finding a solution. The OB Town Council and OB Planning Board are in complete agreement with the OBMA that the San Diego City Council must pass a fair and reasonable Sidewalk Vending Ordinance that doesn't cause our community to lose its park at the foot of Newport Ave. Parks and their grassy areas were never meant to have this constant and often daily overuse by a handful of vendors.

We know that this has been a huge frustration for so many of our members and we join you in that frustration.
