The Spear Shack

In September 2007, Morgan opened the first free diving retail shop in Ocean Beach. Spear Shack is located at 4810 Santa Monica Ave. and offers tons of gear for free diving and spear fishing, as well as kite boarding.

Morgan grew up in or on the water and traveled the world on by sailboat from age 8 to 15. Once he picked up a spear, he said he was hooked. He managed a dive shop for 15 years be-



fore opening the Spear Shack. "I'm passionate about free diving and spear fishing," explained Morgan when asked why he chose to open his own shop in Ocean Beach. "It's close to the water so customers can test and demo equipment easily and Point Loma is one of the best places in San Diego for spear fishing".

Morgan takes his customers and regulars out on his 18-foot boat to try new products and purchases. He also offers a retail line of kite boards. If you are interested in trying out kite boarding before committing to buying the equipment, Mark offers a 3-hour intro lesson for only \$100, which includes all equipment, at Dog Beach.

If you get a chance, stop by the shop and check out Mark's photo albums and trophies. At the very least you will be amazed at some of the fish he caught, and possibly you'll get the bug to get in the water this summer and try it yourself. The Scoop on Credit Cards

A story appeared in the news recently about consumers' rights to use their credit card without paying fees, so business owners must take extra caution when it comes to honoring credit cards. Whether according to Visa policy or California law, setting a minimum purchase amount or charging a fee for credit card transactions could cost business owners more than the swipe of a card: Visa policy states, "Imposing minimum or maximum purchase amounts in order to accept a Visa card transaction is a violation of the Visa rules." Surcharges are also prohibited, but Visa allows merchants to offer discounts to consumers who opt to pay cash. Even though a \$2 credit card purchase can cost in the short-run, Visa considers those transactions a cost of doing business, and may revoke any account they find attempting to cover those costs. The state of California just says it's illegal: California Civil Code 1748.1.a (of the Song-Beverly Credit Card Act of 1971) states, "No retailer in any sales, service, or lease transaction with a consumer may impose a surcharge on a cardholder who elects to use a credit card in lieu of payment by cash, check, or similar means." The code also offers the solution of offering discounts to those who pay by cash.

While policies and civil codes may be open to interpretation the scoop on credit cards is this: <u>Charge fees or set minimums at your own risk!</u> For more information, refer to <u>www.usa.visa.com</u> or <u>www.leginfo.ca.gov</u> to view the policies and regulations.

OBSTRUCTING OUR SIDEWALKS!

Many of you may have noticed large groups of seemingly homeless individuals lying around on our sidewalks in front of our businesses. If you and your customers need to step over these people or if you are panhandled by them, what are your rights? We asked Paige Hazard from the City Attorney's Office about people obstructing our sidewalks. Here is the code that deals with this:

647c. "Every person who willfully and maliciously obstructs the free movement of any person on any street, sidewalk, or other public place or on or in any place open to the public is guilty of a misdemeanor. Nothing in this section affects the power of a county or a city to regulate conduct upon a street, sidewalk or other public place or on or in a place open to the public."
